



WORD FROM THE MAYOR

It has been over a year that the Councillors and I have been in office and we are still just as excited about fulfilling the mandate you gave us. Over the past year, we have been actively working to find solutions to many of the issues that have been brought to our attention and we won't let up.

First of all, we looked into the issue of neighborhood security. New bus shelters have been installed and new signs have been put in place to control traffic in residential areas. In the same spirit, school corridors have been created to ensure the safety of young pedestrians. We must stress the fact that neighborhood security depends on everyone – it is a collective responsibility.

We occupy a territory where it is possible to get around easily on foot, which is why the path along Boulevard Perrot, between Grand and du Souvenir, has been redesigned. The redevelopment of the path will continue later in the spring with additional lighting and street furniture. We intend to make it a friendly zone, both for those who use it to take the train and those who simply wish to enjoy a place for relaxing. Furthermore, the boat ramp behind the filtration plant was rebuilt in the fall of 2018. In the summer of 2019, the ramp will be reserved for the exclusive use of City of L'Île-Perrot residents.

In 2018, we developed a new visual identity for the territory and new signs will be installed at the various access points to the City during the year.

From July 12th to 14th, we will hold communal celebrations with the City of Notre-Dame-de-l'Île-Perrot. Our goal is to combine our strengths, so as to offer major events to residents of both cities. Be assured, activities will take place in both territories and we will respect the spirit of the civic holiday, that is to say, an event accessible to all, where residents can come together and share in some enjoyable recreation activities!

Regarding traffic congestion, the City Council is currently evaluating various options to improve traffic flow, especially on boulevard Perrot. This improvement will necessarily ease traffic on other streets.

Following the request of the ministère des Affaires municipales et de l'Habitation, we will implement the action plan to install water meters during 2019.

I am also very pleased to announce the appointment of the new City Manager, Nancy Forget, who took office in December 2018. She brings a new breath of air and will be a great asset in helping us achieve the vision we have for L'Île-Perrot. I would also like to thank all the employees for their invaluable contribution to City projects.

In closing, I would like, on behalf of City Council, to offer you our best wishes for 2019. We will continue to work together to create a sense of pride in a great place to live.

NOTICE TO CITIZENS

ALERTS AND INFORMATION SYSTEM: STAY INFORMED!

The City of L'Île-Perrot's computerized information and alerts system is used primarily to inform residents of specific health and safety events, such as boil water advisories, water main breaks, street closures, etc. Our goal is to reach and inform affected residents as rapidly as possible. WINTER PARKING

Winter parking on the street is prohibited from November 15 to April 1 between midnight and 7:00 AM, unless otherwise stated. The City does permit parking, under certain conditions. To find out if parking will be authorized for the coming night, call 514-453-1664 or visit the website after 5:00 PM.

The decision to allow or prohibit parking will depend on weather conditions and snow clearing operations by the Public Works Department. It is the responsibility of all vehicle owners to consult the notice before leaving their car parked during the stipulated hours.

COLLECTION OF GARBAGE AND FOOD WASTE

Since January 2, 2019, garbage is collected every two weeks during winter between November and April. Collections will remain weekly during the summer period, from May to October.

In 2018, food waste collection was implemented in residential buildings of four units or less. Collection will be extended to residences of five units and over as of October 2019.
